#### 3.1 Declaration of dangerous dog

WHEREAS Council has reviewed all of the details of the animal at large complaints regarding Walter Poynting's dog(brown in color), has heard the By-law Enforcement Officer's recommendation of the dog, which has been in quarantine for the past fifteen(15) days as per By-law 1/2004 Section 11 (3), and has heard from the owner, and his

WHEREAS it is Council's determination that because the dog in question has pursued, menaced, threatened, attacked, bitten and injured individuals and other animals on several occasions, and

WHEREAS phone calls and warning letters were sent to Mr. Poynting at no avail, and visits from the By-law Enforcement Officer were ignored, and

WHEREAS even when unprovoked, the dog is a threat to the well being and safety of others, and

WHEREAS in regards for the safety of community members, children, seniors and other animals, Council hereby declares

Mr. Walter Poynting's brown dog a dangerous animal and a threat to society,

THEREFORE BE IT RESOLVED that Council hereby declares the dog in question as a dangerous animal and directs the By-law Enforcement Officer to arrange for euthanasia of the dog as soon as possible.

BE IT FURTHER RESOLVED that all costs associated with the enforcement of this dog be invoiced to Mr. Walter Poynting, and failure to pay said invoice will result in the costs being added to the property owners taxes know as 436 Grenon Ave. Winnipegosis, MB.
